For all the **Approach S2/S4/S6**, the serial number is located on the back of the watch face. Serial number prefix includes: 30Y, 31G, 310, 3C9, 3P0, 3CA, 3D8, 3D7, 3GR

For the **Approach G7**, the serial number is located on the back of the device. Serial number prefix include: 3GE

For the **Approach G8**, the serial number is located on the back of the device, underneath the USB cover port. To access the serial number you need to lift the USB cover port cover to display this serial number. Serial number prefix include: 3EC

For all Garmin products the serial number can also be located on the original product packaging. The serial number label is located on the top of the box in the upper corner.
